Establishment and structuring of companies and joint ventures

- Advising on the conceptual design of the company and choice of corporate form in light of individual needs and criteria, e.g. the type of company or sector, business plan, options for raising capital and financing, commercial risks, the number of founding shareholders, profit and loss sharing, taxes, shareholder liability, directors' powers and powers of representation, accounting requirements, shareholder voting and co-determination rights, holding structures, partnerships or joint stock companies
